



CUTEST COUPLE CONTEST RULES

These rules apply to HD 98.3 Cutest Couple Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WHHD (“Station”). **In addition, the General Contest Rules posted at www.hd983.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on January 29, 2019 and end on February 24, 2019.
- b. To enter online, visit www.hd983.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on January 29, 2019 at 8:00 a.m. Eastern Time (“ET”) and ending on February 24, 2019 at 5:00 p.m. Eastern Time (“ET”) (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per couple during the Online Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. Each online entry form must also include a Cutest Couple Photo (“Photo”). This can be a romantic couple or a friendship couple, but both partners **MUST** be 21 years or older.
- d. Each Photo submitted may feature only the couple and must not contain copyrighted materials or any other materials that may be restricted, prohibited, or outlawed by any laws, or materials that may otherwise infringe on the rights of a third party. Entrant acknowledges and agrees that professional photographs (i.e., photographs taken by a photographer who was paid to take such photographs) are not eligible unless the entrant has rights to post that Photo. The Photo may not invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person’s personal or proprietary rights including but not limited to copyrights or trademarks. The Station shall have the right to disqualify any entrant if it determines that the Photo contains copyrighted material or material that infringes on the rights of another; indecent or otherwise offensive material such as violence or drug abuse; or if such

Photo contains material that is deemed to be unsuitable for a public audience. The Station's determinations with respect to all such matters shall be made in its sole discretion and shall be final. Photos that do not comply with these rules will not be eligible for the Contest.

- e. There will be up to a total of one (1) winning couple selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Columbia, Richmond, Burke, McDuffie, Glascock, Hancock, Jefferson, Jenkins, Taliaferro, Warren, Washington, Wilkes, and Lincoln Counties, GA and Aiken, Allendale, Barnwell, McCormick, and Edgefield Counties, SC, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) prize will be awarded. The prize is being provided by Warner Brothers Records and consists of the following: (i) Two (2) General Admission tickets to Lukas Graham at the Chicago House of Blues on March 10, 2019; (ii) Roundtrip airfare for two (2) departing from an Augusta, GA area airport to a Chicago, IL area airport; and (iii) one (1) night(s) hotel accommodations for two (2) (standard room, double occupancy) in Chicago, IL. Approximate Retail Value of the prize is \$2,000.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or

unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the non-awarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip.

The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party.

Prize or prize certificate must be claimed within two (2) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to one (1) winning couple will be selected as follows:

Each eligible Photo will be posted for voting on the Station as they are submitted and approved and ending on February 24, 2019 at 5:00pm ET. The one (1) couple with the most votes will be deemed the winning couple, upon confirmation of eligibility.

In the case of a tie, the Station will randomly select the winning couple that have tied in votes. Potential winning couple will be notified by telephone and/or email on Monday, February 25, 2019 after the voting period has ended.

- b. Voting is limited to one vote per verified email address per day.
- c. Entrants need not listen to the Station or be present to win.

- d. Winning couple must confirm acceptance of prize within twenty-four (24) hours of winning, or risk disqualification and selection of an alternate winning couple (time permitting) from the next Photo that acquired the most votes.
- e. Decisions of Station management with respect to the Contest are final.
