



HD Flashback Photo Booth CONTEST RULES

These rules apply to HD Flashback Photo Booth Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WHHD (“Station”). **In addition, the General Contest Rules posted at www.hd983.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on June 4, 2020 and end on June 25, 2020.
- b. To enter online, visit www.hd983.com and follow the links and instructions to enter the Contest and complete and submit the online entry form including your photo beginning on June 4, 2020 at 8:00 a.m. Eastern Time (“ET”) and ending on June 25, 2020 at 11:59 p.m. Eastern Time (“ET”) (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per person during the Online Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator. **The same Photo may not be submitted more than once.**
- c. Photos submitted on the Stations’ websites must be in gif, jpeg, jpg, or png and may not be larger than 500 MB. Obscene, provocative, or otherwise objectionable content will not be considered, and such determination is solely at the discretion of the Stations. Each Photo submitted must not contain copyrighted materials or any other materials that may be restricted, prohibited, or outlawed by any laws, or materials that may otherwise infringe on the rights of a third party. The Photo may not invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person’s personal or proprietary rights including but not limited to copyrights or trademarks. The Stations shall have the right to disqualify any entrant if it determines that the Photo contains copyrighted material or material that infringes on the rights of another; indecent or otherwise offensive material such as violence or drug abuse; or if such Photo contains material that is deemed to be unsuitable for a public audience. Photos may be posted on the Stations’ websites at www.hd983.com and www.kicks99.com and by submitting a Photo, entrant (1) certifies that he or she has all rights necessary to use the Photo, and (2) grants Stations permission to use the Photo for Contest and other promotional purposes. The Stations’ determinations with respect to all such matters shall be made in its sole discretion and shall be final.

Photos that do not comply with these rules will not be eligible for the Contest.

- d. There will be up to a total of ten (10) winners selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Columbia, Richmond, Burke, McDuffie, Glascock, Hancock, Jefferson, Jenkins, Taliaferro, Warren, Washington, Wilkes, and Lincoln Counties, GA and Aiken, Allendale, Barnwell, McCormick, and Edgefield Counties, SC, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to ten (10) prize packs will be awarded. Each prize pack is being provided by Elektra Records and consists of the following: (i) One (1) Twenty One Pilots 2020 Tour T-shirt and one (1) face covering. Approximate Retail Value of the prize is \$40.
- b. Prizes or prize certificates must be claimed at the office of the Station located at 4051 Jimmie Dyess Pkwy, Augusta, GA 30909 Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within two (2) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to ten (10) winners will be selected at approximately 10:00am ET on Friday, June 26, 2020 in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Prize winner will be notified by phone and/or email promptly following the random drawing. Entries will not be judged for the purpose of selecting a winner.
- b. Odds of winning depend on the number of eligible online entries received during the Online Entry Period.
- c. Entrants need not listen to the Station or be present to win.
- d. Winner must confirm acceptance of prize within 30 days of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries. Decisions of Station management with respect to the Contest are final.
